PRIVACY NOTICE

1. Introduction

In compliance with the Personal Data Protection Act 2010 ("the Act") and its regulations, this notice is issued to all our valued visitors, customers and/ or prospective customers ("user", "you", "your"). This Notice will inform you of your rights with regards to your personal data that has been and/ or will be, collected and processed by us for the purposes mentioned herein.

The Food Purveyor herein refer as **TFP** and its subsidiaries (each, the "**Company**" and collectively, the "**Group**") needs to gather and use certain information about individuals. These can include customers, suppliers, business contacts, employees, and any other people who the organisation has a relationship with or may need to contact with by the Company.

This policy describes how this personal data must be collected, handled, and stored to meet the company's data protection standards — and to comply with the relevant laws and regulations.

2. Collection of personal data

We have collected and will collect your personal data to be processed by us and/ or on your behalf in the course of your present or future dealings with TFP, its subsidiary (ies), its associated company (ies) ("we", "our", "us" or "Company"). 3. Description of personal data

- e) When ordering or registering, we may ask you for your name, email address, mailing address, phone number, credit card information or other information. You may, however, visit our site anonymously.
- g) We also collect information about gift recipients so that we can fulfill the gift purchase. The information we collect about gift recipients is not used for marketing purposes.
- h) personal preference and interests, including post-transactions and spending behaviour; including feedbacks and opinions such as testimonies, reviews and rating of our products and services;
- i) device related information such as hardware information, IMEI number, UUID (unique identifier), equipment devices model, application version serial number, current software version, mobile country code, mobile network code, device operating system version, settings of the device used to access the Website, IP address; and
- j) logged-in related information such as browser information, geolocation information, IP address information, time and duration of your use Website, diagnostic, technical error and view of usage information page.
- k) Sensitive personal data; and any
- l) Personally Identifiable Information (PII) defined by international privacy laws or standards.

4. Purpose of collection of personal data

You hereby agree that the Personal Data may be used by the Company, including but not limited to the following purposes:

- a) to update relevant information;
- b) to process the application for related services or contest;
- c) to manage, operate, including audit and exercising the rights of the Company under these terms and conditions;
- d) to design new or improving existing services provided by Company and our affiliates;

- h) to disclose to the relevant authorities as required by law, rules, regulations, codes, or guidelines; and

- e) Business cards.

6. Disclosure of personal data

While the User's Personal Data shall be kept confidential by the Company, by voluntary disclosure of your personal data to the Company, you agree that for the purposes as stated above, the Company may transfer or disclose such Personal Data to the following Third Parties within or outside of Malaysia as permitted by the laws:

- (a) any participating companies which owe a duty of confidentiality to the Company and which the User has selected to submit or register;
- (b) the Company's agents or contractors under a duty of confidentiality to the Company which are providing administrative, telecommunications, data processing or other services to the Company in relation with the operation of the Card, Programme or business of the Company (such as but not limited to professional advisers, customer call centre service providers, gift redemption centres or data entry companies);
- (c) any of our affiliates which owe a duty of care to the Company; and
- (d) any law enforcement agency and/or regulatory body for compliance with applicable laws, rules, regulations, codes and/or guidelines and/or any person or entity to whom the Company and/or its affiliates are under a binding obligation to make disclosure under the requirements of any law, rule, regulations, code and/or guideline and/or order of any competent court of law, law enforcement agencies and/or regulatory bodies.
- (e) While nothing in the terms and conditions stated herein shall limit your rights under the Act, you shall also have the right to limit the processing of your personal data at any time hereinafter pursuant to with any applicable laws.

The cookies used by the Company's Website is not in any way collect personal data that could be used to identify a specific user. In addition, cookies are of a temporary nature, used solely to improve the efficiency of the last transmission. Users may configure their browser to notify them of the reception of cookies and to prevent their installation on their computer.

10. Transfer of Personal Data

We are very serious about providing a comparable level of protection for personal data should the information be processed or used outside of Malaysia by our vendors or experts as permitted by laws.
